



Equipment Demo Day – Release from Liability Waiver/Assumption of Risk Agreement

This Agreement reflects that the ND Construction Leadership Council (NDCLC) in cooperation with General Equipment & Supplies, Inc (GES) desires to assist high school, college students or an individual with an interest in our industry to discover whether they want to pursue a future career in the profession by offering the opportunity to operate equipment and network. Participants must be at least 16 years of age and enrolled in high school or college courses, an NDCLC member, or an individual who has expressed interest in joining the construction industry.

As a participant of Demo Day, I understand and agree:

1. I will wear a mask when interacting within 6 feet of other individuals and practice standard social distancing and hygienic protocols. If I develop COVID symptoms after attending the event I will email ndclc@agcnd.org.
2. I will follow the directions of my assigned NDCLC trainer(s) or GES employee(s).
3. I will follow the Safety protocol as directed by my assigned NDCLC trainer(s) or GES employee(s).
4. I will dress appropriate for field condition. (Close toed shoes, preferably steel toed, are required).
5. NDCLC and GES will not be held responsible for any accident, injury, accidental death, illness, or damaged property that may occur on its premises. I hereby agree to indemnify and hold harmless NDCLC and GES from any claim or demand on account of injury or damage that I may suffer as a result of the Equipment Demo Day.
6. I understand that my participation in Equipment Demo Day is voluntary and that participating can, in some cases, cause injuries, including potentially severe injuries. I am familiar with the potential risks and assume all such risk.
7. NDCLC or GES shall have the right to immediately terminate my participation in the program if it is determined that I am not acting in the best interest of the company.

I have read this agreement and Release and Waiver of Liability and understand that NDCLC and GES cannot be liable for any injuries or illness that I may suffer. I expressly waive any such claim for compensation or liability on the part of NDCLC and GES in the event of such injury or medical expense.
